

Spring Member Meeting Motions April 2, 2024

Mixed League:

6.25. One point will be awarded for each Match won for a total of 6 points per Fixture.

Proposed (revised):

6.25 Each individual match will be worth 3 points.

If a team wins in straight sets they will be awarded 3 points for the match. For 3 set matches, One point will be awarded for each set won including 3rd set tiebreaks. No points will be awarded for any uncompleted set or tie-break

<u>Ladies League:</u>

Replace rule 3.d.)

d). Scoring for Untimed matches, Match format is best 2 out of 3 complete sets, with the following four provisions for playing a 10-point Super Tie-Break for the third set.

- (i) In the event that Matches take place indoors all Matches must be played to completion. A Super (10 point) Tie-Breaker may be played instead of a third set .
- (ii) The home Club can mandate Teams to play a Super Tie-Break for any Match, including after split sets, in order to accommodate Club programming.
- (iii) Players may decide prior to commencement of play to use the Super Tie-Break. A majority decision (ie. 3 of the 4 Players) involved in the Match is needed.
- ❖ Comment: The decision to use a Super Tie-Break may be used for any reason (delayed start, poor weather coming, heat, cold, kid camps etc.). If known prior to the start of the Fixture, home Team Captains should communicate any Club requirements so all Players know.

Replace D with All matches will be best 2 of 3 sets regular play with a 3rd set 10 point super tie breaker.

Add rule 3 e.) All matches to be maximum 2 hours in length.

Junior League:

<u>L1 3)</u>

Junior Mixed: UTR / WTN Verified Matches SUN PM: 4 pro sets to 8 games (2 divisions: "A" – UTR <= 24; "Majors" – UTR > 24 for combined 4 players)

<u>T1E</u>

Junior Mixed: Teams must have a minimum of 2 boys and 2 girls on the roster T2G

A player in the Junior Mixed League can play 1 boys or girls doubles match and 1 mixed doubles match.

<u>F1C</u>

Junior Mixed League: A fixture consists of 4 matches: 2 doubles matches - 1 Boys and 1 Girls 2 mixed doubles matches

Ratified at last ICTA Board Meeting: Junior League team fee will be increased from \$40 to \$50

Heat and Air Quality Motion:

On days where Environment Canada has issued a heat warning or air quality is considered high risk or very high risk, and the warning is in effect 2 hours before the start of a scheduled fixture, the home captain will contact the visiting captain to confirm that all matches are cancelled and will be rescheduled for another date.

Paid Player Motion:

INTERPRETATION

Compensation: refers to any financial remuneration, goods, services or benefits received directly or indirectly in exchange for playing.

NEW TEXT RULE

Players cannot be compensated in any way for play within the ICTA as per our By-laws. Any person receiving compensation of any kind for ICTA play, or any person from a member club found to be involved in compensating a player for play within the ICTA, or Teams found to have compensated a player, will face disciplinary action up to and including expulsion from ICTA leagues. All disciplinary action will be decided by a disciplinary committee convened by the ICTA Board.
